Mr. Karatassos stated that this morning at 11:19 he recieved an email from Fultoncountylegal@gmail.com stating "I know that a few of your employees have tested positive for Covid. According to the state of Georgia You are supposed to shut down the restaurant yet you have ordered upper management to keep quiet and stay open BAU and not record their temps. That is a not ok. I also have documented proof you have multiple illegal aliens working in your restaurant group. Specifically in atlanta where they are clocking in and out under other peoples social security numbers, that is also illegal. Like I said, I have documented proof of my claims in this email and so much more about the illegal practices of your business. I plan on contacting the NYC reporter that was in the restaurant a day ago. I will be going to the press by 7:30 am Friday morning if \$10,000 Isn't wired to my account. Write back for the account details "

Mr. Karatassos stated that he then recieved another email at 1:26 pm from the same person stating that he has less than 24 hours to wire the \$10,000.

At 2:13 Mr. Karatassos recieved an email stating "Two of the kitchen staff employees have tested positive for Covid 19. Niko karastosas the controller of the company has threatened us all silent. I can't stand by and allow this to continue knowing that they could be infecting someone. Both employees were working during mother day service.
